

OPEN ACCESS AGREEMENTS WITH QATAR NATIONAL LIBRARY

Your institution is participating in Springer Nature's fully open access agreement with Qatar National Library including fully open access journals from BMC, Nature Research and SpringerOpen. At the same time you can continue to take advantage of the Read and Publish (Springer Compact) open access agreement. This combines the cost of article processing charges (APCs) with subscription content access fees. Under the Read and Publish agreement your researchers can publish their articles open access in Springer hybrid journals at no extra cost and access the full text of Springer subscription journal content. The costs to them are covered by your institution and authors are not required to make additional payments.

Both agreements promote the transition to more transparent and sustainable open access publishing, and reduce the total financial cost and administration whilst enabling researchers to comply with their funders' open access requirements.

Three ways to promote and support open access publishing under your agreements

If your institution is part of these open access agreements make sure your users and researchers know about it. We have summarised some ideas that might help you to further promote and support open access publishing in your organisation.

1. Make sure your corresponding authors know how to publish under your open access agreements

Once an article has been accepted for publication, corresponding authors will be sent a link where they will be asked to confirm their institutional affiliation.

There are three ways that Springer Nature can recognise eligibility for coverage under the open access agreements. Corresponding authors should ensure at least one of the below parameters matches our author identification check.
