Sample size	n = 84 (17 AD patients, 18 mild cognitive impairment, 16 no cognitive impairment, 9 vascular dementia, 12 vascular mild cognitive impairment, 12 acute stroke). All samples were age-matched. We used a comparable number of samples from each clinical group for correlational analysis of APEX blood measurements (exosome-bound, unbound and total circulating Ab) with brain plaque deposition. The correlation of determination (R ²) was performed at 95% confidence interval for all samples.

Replication	All measurements were performed as triplicates and all data were presented.

Blinding	All experiments were performed blinded from clinical diagnoses and PET measurements.
