Life sciences study design

Sample size	Sample size on animal phenotyping studies were determined based on a power of 90% (5% two-sided) and the standard deviations and signal/noise ratios generally observed in ipGTT studies, which led us to use 8 animals per group and cohort in low fat diet studies, and 10 animals per group and cohort on high-fat diet studies. Based on 15 years of animal experimentation, we further added two additional mice per group and cohort, as mice might be lost due to non-experimental procedures (mostly aggression between mice). For primary hepatocytes-based experiments, sample size was determined in a case by case fashion depending on the experimental readout
Data exclusions	In our high-fat diet intervention, mice were excluded if they lost more than 20% in 7 days (3 cases during all our experiments, all caused by aggression by other mice). Similarly, once we established no differences in body weight between genotypes, mice whose body weight remained constant or did not increase after 5 weeks of high-fat diet, were excluded. This applied to ~5% of the high-fat fed mice used in our studies, with equal distribution between genotypes.
Replication	All animal studies were replicated at least in two independent cohorts. All cell-based studies were performed and replicated at least 3 independent times.
Randomization	Animals were distributed in a random fashion between experimental groups
Blinding	The genotype of the animals was blinded when performing metabolic phenotyping analyses. Samples were also blinded for metabolomic analyses. Image acquisition and quantification were also performed in a blinded fashion.
