Sample size	Our sample size of 13 was larger than initially expected. In previous studies (Li/VanHooser et al. 2008), 5 animals were sufficient to see a large effect. But we saw a surprising effect, and then doubled our sample size to ensure the reliability of the results.
Data exclusions	No exclusion
Replication	After 7 experiments had been performed, we surmised the effect. Then 6 additional experiments were carried out. These experiments were consistent with the initial 7.
Randomization	Experiments were planned on a given day; ferrets had either opened their eyes or not (there is variation in eye opening). This natural variation as well as the variation in the day of birth and the availability of the microscope contributed the random variation.
Blinding	The division of animals into "immature" and "mature" was not done until after the fact (that is, the dependency was a surprise), so investigators were "blind" to the meaning of this condition.
