Data collection

Single crystal X-ray diffraction data collection was performed using Blu-Ice 5.0 software. The stopped-flow fluorescence data were collected using the ProData ChiraScan software (Applied Photophysics).

Data analysis

X-ray diffraction data processing was performed using HKL2000 v716.1 software. CCP4 6.5, PHENIX 1.10, and CNS 1.3_r8 were used for model building, refinement, map generation, and validation. Maximum likelihood structure superimposition was done using Theseus 2.0.1. Curve fitting of the stopped-flow fluorescence data was performed using KaleidaGraph 4.1.3.
