Sample size	In order to construct an comprehensive gene catalog and recover MAGs of the pig gut microbiome, we collected as many samples as possible from a wide range of sample sources spanning various ages, sexes, breeds, geographical areas, domestication and gut locations. The 500 samples used for analysis included 472 feces, 20 cecum lumen, 6 ileal lumen, and 2 jejunum lumen contents from 8 different pig breeds or Western × Chinese cross populations from eight farms. In addition, to expand the gene catalog of the current study, the complete genes from 7,685,872 non-redundant genes in the gene catalog of the pig gut microbiome using 287 pig samples reported previously were integrated.
Data exclusions	The sequencing data with the contamination of host genomic DNA > 80% were excluded. Thus, the sequencing data of 500 samples used for assembly had at least 4Gb of clean data. Incomplete genes were excluded from the gene catalog. The metagenome assembled genomes with completeness <50% or contamination >5% were excluded from the catalog of MAGs.
Replication	As a discovery project, the purpose of this study is to construct catalog of microbial genes and metagenome assembled genomes from the pig gut microbiome. A total of 787 samples were included. This is not relevant to this study.

Laboratory animals

A total of 470 pigs from a Mosaic population, a cross line, five domestic purebreds, and wild boars were gathered and used in this study. These pigs included 174 males and 287 females and between 25 and 951 days old. Six samples were pooled from male and female pigs at the age of 300 days. Three wild boars were not recorded sex, and the exact ages of all wild boars were unknown.

Wild animals

We captured eight adult wild boars using tranquilizer guns from mountains, including three males, two females and three individuals having no record about sex. The exact ages of all wild boars were unknown. In order to collect samples from different gut locations, all wild boars were anesthetized and transported to the laboratory. After sampling, all other parts were disposed properly. The project was supported by the government and Animal Care and Use Committee (ACUC) in Jiangxi Agricultural University.

Field-collected samples All experimental pigs were sampled under standard procedures within 30 min after slaughter at room temperature.
