Life sciences study design

Sample size	Single nuclei profiled in this experiment were sampled from 1g of root tissue, comprising hundreds of individual seedlings. Nuclei were loaded as to not overload lanes of the 10X Genomics Chromium. No sample size calculation was completed before isolating single cells, as individual biological samples (seedlings) could not be distinguished in the final single-cell output. Otherwise, the amount of tissue input to the 10X Chromium was selected based on manufacturer's specifications.
Data exclusions	While no data were excluded from analyses, three clusters of cells described in the manuscript showed no specific accessibility markers, precluding their annotation.
Replication	Many biological replicates (pools of seedlings) are included in the developing root sample described in the manuscript, but no single-cell experiments for additional pools of seedlings were completed due to the cost prohibitive nature of this technology in its current form.
Randomization	N/A - There was no treatment/perturbation compared to a control in this study.
