Replication	A single independent replication of the findings from this observational study was sought in an independent sample of 870 individual with schizophrenia also obtained from Danish national health registries. Of the thirteen described associations five were significant ($p < 0.05$) in the replication sample while twelve showed sign-concordance.
Randomization	Since this is an observational study, no randomization was performed. In the comparison between individuals with schizophrenia and population controls, we matched individuals according to age and sex.

Population characteristics	The case population consisted of 5432 individuals with schizophrenia (3037 male, 2395 female) all born between May 1, 1981 and Dec 31, 2002 diagnosed with schizophrenia before Dec 31, 2012. 3790 of these had other psychiatric diagnoses prior to the schizophrenia diagnosis.
Recruitment	Patients were recruited according to consent by non-opt out from a national research program in which very few individuals opt out. Our control sample was drawn nearly randomly from the national biobank making the potential for ascertainment effect negligible. Our case cohort is the complete population as of 2012, which is young for psychiatric disorders meaning there may be some enrichment for early onset and some yet-to-convert cases in the controls for anyone disorder. These are unlikely to effect most of our results.
Ethics oversight	The study protocol was approved by The Central Denmark Region Committees on Health Research Ethics. The use of this data is according the guidelines provided by the Danish Scientific Ethics Committee, the Danish Health Data Authority, the Danish data protection agency and the Danish Neonatal Screening Biobank Steering Committee. At time of blood sampling, parents were informed in writing that the blood spots are stored in the Danish Neonatal Screening Biobank and can be used for research, pending approval from relevant authorities and about how to prevent or withdraw the sample from inclusion in research studies.
