Sample size	A total of 207 LIP neurons were collected and analyzed in two monkeys. Most monkey electrophysiology studies follow the convention of using two animals.

Replication	Following the convention of the field, we replicated the experiments and analyses in two animals. The main conclusions were replicated in both animals, and the differences are described and explained in the manuscript.
Randomization	The animals were chosen based on availability. The conditions were pseudo-randomized in each trial. The neurons were chosen based on availability.
Blinding	Not possible for data collection. Only one experimenter collected data for most of the time and analysed all data
