Sample size

No specific calculations were used to determine sample size for each experiment. All experiments were performed with sample sizes of n = 3 unless otherwise state. Sample sizes of n=2 were used in screening initial protein mutant candidates, and a third replicate was performed with strong positive activity hits. Selected sample sizes were consistent with previous comparable studies in the field (Johannes et al. Biotechnology and Bioengineering, 98, 2006. Woodyer et al. FEBS, 272, 2005. Beyer et al. Appl Microbiol Biotechnol, 101, 2017.)
