Study description	We used previously published data of depth, latitude, and speciation rates for 4,067 perciform fishes to test for the relationship between latitude and depth evolution across fishes.
Research sample	Our dataset encompasses information for 4,067 perciform species, which represents the largest sampling of fishes globally with associated phylogenetic information.
Sampling strategy	All perciform species with available phylogenetic information, as well as data on depth and species distribution were included in this study.
Data collection	Data were previously published and no additional data were collected for this study.
Timing and spatial scale	Our data span global extant fish species. All data for this study were collated from previously published sources in Fall of 2020.
Data exclusions	No data were excluded from analyses.
Reproducibility	All evolutionary analyses were repeated with multiple depth schemas, on three different phylogenetic trees and across trees with variable species sampling, all with qualitatively similar results.
