Sample size	No sample size calculation was performed. Kinetic assays (with the exception of Supplementary Fig. 3) and whole cell over-expression data were performed with 3 technical repeats and with multiple biological repeats. The 14C assay was performed with 3 biological repeats. The reproducibility of the biological repeats determined that these sample sizes were sufficient. The 14C whole cell labeling (Supplementary Fig. 2) was performed in singlet and Fgd1 kinetic assay (Supplementary Fig. 3) was performed in duplicate due to substrate availability and time limitation.
Data exclusions	Data were excluded on observing anomalous results (deviating from technical and biological repeats) and were omitted as described in the manuscript.
Replication	Reproducibility of experimental findings were confirmed with technical and biological replicates of all experiments with the exception of 14C whole cell labeling (Supplementary), which was performed once due to substrate availability and time limitation.
Randomization	Randomization was not applicable to this study. Defined drug/substrate concentrations were required and all samples were analyzed.
Blinding	Blinding was not relevant to this study. Data was collected without bias - drug/substrate concentrations required in each experiment were not defined at data collection. Subsequently, defined drug/substrate concentrations were required upon data analysis.
