Data collection	National Instruments LabVIEW 2020 software was used to control power supplies for electrospray experiments. The custom LabView script is available from the corresponding author on reasonable request. UV-visible spectrophotometry data was collected using the Jasco Spectra Manager I software. Nanodrop data was collected using Nanodrop 2000/2000c software. Measurements made via Tecan platereader were collected using the i-control V 3.37 Infinite Microplate Reader software.
Data analysis	Rhodamine UV-vis efficiency measurements were calculated using a custom script with MATLAB R2022a. All statistical analyses were performed using Prism 9 software. The custom MATLAB script used to analyze the rhodamine UV-vis data is available from the corresponding author on reasonable request. The COMSOL 6.0 simulation file used for the simulation is also available.

Sample size

A sample size of 6 was chosen for determining the efficiencies of our materials when using UV-visible spectroscopy to determine efficiency. This was done to allow enough samples to ensure reproducibility across results. For more rigorous methods of efficiency determination, such as high-performance liquid chromatography, a lesser sample size of 3 was selected as this process is highly precise but also costly.

Data exclusions

No data was excluded unless protocol severely deviated from that reported in the methods (e.g., running out of solution mid-experiment, power spike in supply, air bubble in tubing).

Replication

Reproducibility was conducted by having a sample size of 6 for the materials used using UV-vis for efficiency determination. This method for efficiency calculation was then validated by other methods of determining efficiency (e.g.: HPLC, Nanodrop, Pierce 660 nm assay, trehalose assay). The efficiency from UV-vis was deemed statistically insignificant with 95% confidence compared to these other methods measuring efficiency. All attempts were successful.

Randomization

Randomization was not applicable to this study as the materials used in the study were all subjected to the same experimental parameters.

Blinding was not relevant to the study as the study used specific materials relevant to life sciences such that the experimental method could be applied for more general uses.
