Life sciences study design

Sample size	Sample size (peptide library with 163 sequences) was expanded based on previous libraries as summarized in Table S3. The selection of the sample size was based on meaningful sequence variations derived from the original 12-mer peptide sequence QCKIKQIINMWQ (EF-C). To create the library, preference was given to sequences shorter than 12-mers, achieved by truncating the C-terminal ("QC") and N-terminal ("NMWQ") residues. Additionally, hydrophobic ("I") and charged ("K") amino acids were substituted with other hydrophobic ("A", "F", "L") and charged ("R") amino acids and sequences were scrambled as outlined in Table S2. Because it is not feasible to create all possible sequence variations and experimentally test them with the methods described herein, a medium-sized library of 163 peptides was selected based on the research budget. This selection ensured representative coverage of a wide range of sequence variations based on the criteria mentioned above. For peptides created by pattern analysis and selected from databases a sample size of 18 and 20 peptides (11 % and 12 % relative to the peptide library size) was chosen according to author's experience and available research budget. No statistical calculation was involved in the determination of the sample size. However, the total sample size (201 peptides) is large relative to other experimental self-assembly peptides data-mining, (e.g 20 experimentally tested peptides in Nat. Chem. 14, 1427–1435 (2022)).

Replication	All virus assays were conducted in technical triplicates. All tested peptides for the virus infectivity assay were conducted at four different concentrations (6.5 μ M, 1.3 μ M, 0.26 μ M, 0 μ M). To verify reproducibility of the experimental findings the assays were at least repeated independently in biological duplicates. To ensure comparability within individual measurements, the reference peptide "EF-C" was included in all assays. All replication attempts were successful.
