Data collection

The kinetic data were collected using PerkinElmer UV WinLab 6.4.0.973. Mass spectrometry data was collected with LC-MS using a Waters 2795 HPLC with ZQ single quadrupole MS. Fluorescence data were collected with a PerkinElmer LS 55 fluorescence spectrometer. The molecular modeling was done in Bioluminate 4.3. QM simulations was done using Gaussian16. Molecular dynamics simulations were done using AMBER 2018. QM/MM calculations were performed with the TeraChem 1.9.3/OpenMM7 interface.

Data analysis

VMD 1.9.3, pyMol2 for Windows and the AMBER2018 cpptraj module were used for analyzing structures and simulation trajectories. PMI-Intact 3.1-19 by Protein Metrics was used to analyze mass spectrometry data. Origin 2021b was used for statistical analysis.
