The HR-LC-MS/MS data was processed by MassHunter software (Agilent), GNPS (<https://gnps.ucsd.edu/>) and MS-Dial version 4.9.2. The antiSMASH version 6.0 was used to predict biosynthetic gene clusters. In mRNA-seq analysis, DESeq2 was used to estimate Differentially Expressed Genes (DEGs) between different treatments. The software g:Profiler and clusterProfiler R package were used in DEGs analysis. BiG-FAM, BiG-SCAPE and CLC Genomics Workbench version 22.0.2 (Qiagen) were employed to conduct comparative genomics analysis. All other softwares used in this study for data analysis were described in the manuscript.
