Sample size	Generally, three biological replicates were adopted for data analysis due to relatively small deviation of microbial cells, which is also standard in our field that is deemed sufficient. For some special experiments, like the preliminary SA fermentation of engineering strains, fewer sample sizes are adopted, as stated in the figure legends.
Data exclusions	No data were excluded from the analysis.
Replication	Succinic acid fermentations using shake flasks were performed with biological triplicates or duplicates. Fermentations in bioreactors was performed with a three replicates. Enzyme activity assay were performed with biological triplicates. Succinic acid recovery, crystallization, and purification were performed with biological duplicates. Metabolic flux analysis were performed with biological triplicates. All attempts at replication were successful.
Randomization	After transformation, ten yeast colonies were randomly picked to select engineered strains with higher SA titer and yield by shaking flasks fermentation. Then the fermentation of high-SA producing strains was repeated. All transformation colonies were allocated into experimental groups, and the started strain was allocated into control group.
Blinding	Not relevant because no group allocation was involved in this study.
