Sample size	Minimum sample size for conductivity retention was estimated based on power analysis using in vitro data. Sample size for safety assessment and electrical mapping was decided to be only n=3, to demonstrate reproducibility as a proof of concept.
Data exclusions	No data was excluded for the analysis
Replication	Safety assessment, in vivo hydrogel formation and electrical mapping studies were done in three different pigs (n=3, biological replicates). The data shown successful replicates is included in the manuscript and SI.
Randomization	No need for randomization, since we were not exploring multiple treatments. No need for covariates since all studies were replicates performed on different days by the same technicians. For pacing experiments, all modalities were tested on each animal.
Blinding	Blinding was not relevant for these studies since we were showing reproducibility and all were treated in the same way.
