Sample size The sample size for high-throughput experiments was determined by the number of clusters generated during sequencing. Most of the sequences had a sample size greater than ~10, which is deemed sufficient for reliable fitting.

Data exclusions Data exceeded our detection limit and failed to have consistent measurement between replicates were excluded from the analysis. Sequences with low binding intensity weren't able to curve-fit were excluded from the analysis.

Replication All high-throughput experiments are done in duplicates. Other experiments are done as listed in the figure captions.

Randomization In RNA-CHAMP, clusters on the chip were randomly synthesized during sequencing.

Blinding During the image acquisition step in RNA-CHAMP, we were blinded to the sequence identity in the images.
