Sample size	A total of 6 single cell datasets were analyzed in total for this study. This is designed to balance coverage of cellular phenotypes across tissues and cell lineages while maintaining computational feasibility given the available resources.
Data exclusions	Beyond dataset downsampling no data was excluded.
Replication	All experiments were replicated across the 6 datasets as well as 10 times within each dataset across different train-test splits.
Randomization	Cells were randomly split into a train or test set. Beyond this the analysis did not require further randomization of the data.
Blinding	Blinding is not relevant for this work because it is not a case control study but rather an investigation of algorithmic properties of cell type assignment.
