No sample-size calculation was performed. We collected a minimum of 10 data sets from at least 5 different samples in order to make sure to perform at least 5 independent measurements.

Data exclusions

About 40% of the cryo-FIB/ET data sets were excluded due to excessive thickness or ice contamination of the lamellae that resulted in poor contrast and impaired tilt series alignment. About 25% of the TEM data sets were excluded due to insufficient staining that resulted in poor contrast.
