Presuming that the 3-year DFS rate for the LDG group is 82.3%, and setting α at 0.025 and β at 90%, with a margin of 16%, we determined that at least 120 patients should be included in each group. Considering a projected dropout rate of 20%, we eventually required a minimum of 150 patients in each group, totaling 300.

Randomization

SAS 9.2 program was utilized to create serial number from 001 to 300, corresponding to the intervention assignment. The data manager (RH.T.) extracted the numbers and performed random assignment of patients in a 1:1 ratio to either the LDG or RDG group prior to surgery.

Because of the impracticality of implementing masking, the study was not blinded after randomization, and the patients were informed about surgical approach. However, the trial coordinators (M.L. and J.B.W.) and pathologists were unaware of the assigned treatment.
