Ecological, evolutionary & environmental sciences study design

Study description

This study focuses on the ecological opportunity (colonization of cold habitats) provided by evolutionary transitions from oviparity (egg-laying) to viviparity (live birth) in female *Liolaemus* lizards. Using previously published information, we assembled a multi-species dataset on reproductive parity mode, diet, substrate use, mean body size of adult females, and mean annual environmental temperature. We combined our dataset with an ultrametric tree to perform evolutionary analyses and test the association between live birth and rates and patterns of body size evolution. We focused this study on mean body size of adult females because they lay eggs or gave birth to hatchlings, allowing us to connect parity mode, colonization of cool environments, and body size evolution.

Research sample

Our dataset was gathered by previously published data and includes information about parity mode (oviparous or viviparous), diet (insectivorous, herbivorous or omnivorous), substrate use (terrestrial or saxicolous), and mean body size of adult females for 133 *Liolaemus* species. References of data sources are included in Supplementary Data 1. For the localities where SVL was measured, we gathered data on mean annual temperature (bio1) from the WorldClim database.

Sampling strategy

We conducted a search of mean body size of adult females for every species included in the most recent published phylogeny of *Liolaemus*. We used two criteria to choose mean body size of females from the literature to build our dataset. 1) We selected papers in which mean SVL from adult females and locality details were provided. 2) When different papers reported mean SVL for the same species, we chose the paper with the highest sample size. For every species for which we found mean body size information, we performed a search for data on parity mode, diet, and substrate use. All the information search was conducted in Google Scholar in English and Spanish.

Data collection

S.F.D.-G., D.E., and C.A.M.-M. recorded all data in an Excel spreadsheet (Supplementary Data 1). All data are accompanied of their respective data sources.

Timing and spatial scale

We assembled our data set between March 2022 and February, 2024.

Data exclusions

No data were excluded of the analyses.

Reproducibility

All evolutionary analyses were performed in triplicate, with qualitatively similar results.

We searched for previously published data on Liolaemus lizards, so randomization was not applicable.
