Sample size

Neurons were selected when showing less than 0.5% refractory period violations and clearly distinguishable waveform to ensure good quality of reconstructed spike trains. We performed a total of 10 experiments for this study. All sample sizes from experimental data are indicated in the legend of the corresponding figure. We did not perform statistical power analysis to determine necessary sample sizes.

Data exclusions

Cells were classified as having an OSR in the control condition when the slope was at least 0.7 or higher. All cells where the peak time point could not be unambiguously determined in any condition were excluded from the analysis.

Replication

We performed each experiment on at least 2 mouse retinas and could replicate the results. This was enough to detect significant differences.

We did not separate data groups in this study.

Blinding was not relevant in our study as groups were derived from whether cells have an OSR or not, based on a threshold set for the slope of the latency, as described in the manuscript.
