Study description We estimate the transmission rate for three enteroviruses in China, Japan and the USA using mechanistic disease modeling. We estimate the climate drivers of enterovirus transmission using temperature, precipitation and humidity data from reanalysis sources.

Research sample All publicly available surveillance data for enteroviruses CVA16 and EVA71 in China (2009 - 2013) and Japan (1982 - 2015), and polio surveillance data from the USA (1940 - 1960).

Sampling strategy We use all data available. For polio, we used all data available from the pre-vaccination era.

Data collection Data is publicly available from the Japan National Institute for Infectious Diseases and the China Center for Disease Control.

Timing and spatial scale Data surveillance occurs weekly. Chinese data was collected as part of a collaboration with China CDC, published online by Takahashi 2016.
