Sample size	In the experiment where single phage particles were to be detected, the sample size was 32 to account for the noise due to the low copy number. In other experiments, each sample was measured using 2 or 3 culture replicates (technical replicates, as described in the figure captions and the Methods); the sample size was chosen based on standard practices in microbiology.
Data exclusions	No data exclusion was involved.
Replication	All experiments were independently repeated 2 or 3 times on different days, using bacterial cultures inoculated by different colonies (biological replicates, as described in the figure captions and the Methods). All reported data were successfully reproduced.
Randomization	There is no group allocation in this study; therefore, randomization or control of covariates is not necessary.
Blinding	When quantifying the precision and accuracy of the phage counting method, the author who performed the OD-based assay was blinded to the identities of the unknown samples (as described in the Methods). Otherwise, blinding was not necessary in other experiments.
