POMC-Cre mice were provided by Joel K. Elmquist and Tiemin Liu from the Southwestern Medical Center. POMC neuron-specific SLC7A14 knockout (SPKO) mice were generated by crossing SLC7A14 flox/flox mice (MARC, Nanjing, China) with POMC-Cre mice. Ai9 (tdTomato) reporter mice, which is Cre-driver lines for cell-type-specific genetic manipulation, were obtained from the Jackson Laboratory. All mice experiments were performed in accordance with the procedures of the Institutional Animal Care and Use Committee at Fudan University or the Shanghai Institute of Nutrition and Health, Chinese Academy of Sciences.
