Sample size	No sample size calculation was performed. For the inference of the phylogenetic tree amino acid sequences of citrate synthase genes were collected from publicly deposited sequences. Sequences were selected to include and represent the diversity of bacteria and archaea phyla that was available at the time of collecting. For biochemical assays and growth curves three replicates were carried out to be able to calculate a standard deviation, ensure robustness of the conclusions and keep the sample sizes experimentally manageable.
