Sample size was initially kept small due to the required lengthy analytic equipment run-time (multiple weeks of run-time for only n = 1) of the large amount of samples that were gathered. Follow-up experiments performed to validate results were performed as n = 3 technical replicates, unless otherwise stated. All HPLC traces are representative traces of n = 3 technical replicates. All experiments of machine-learning predictions were n = 3 technical replicates. Sample sizes were determined based on precedent and were not calculated.
