For the FIB-SEM data, four biological replicates were performed for the gametocyte samples and two biological replicates were performed for the asexual blood stages.

### Data exclusions

No data was purposefully excluded from the analysis. Due to the labour intensive process of segmentation of cellular features, not all cells present in the FIB-SEM imaging stacks were analysed. However not reconstructed cells were nevertheless inspected and checked for feature consistency as far as that is possible without reconstruction.
