Sample size	We used all annotated and reviewed proteins available in Uniprot prior to a 2022 date cutoff for training Protein-vec. These were the train-test splits chosen by the model that we use as an illustrative example for much of the paper
Data exclusions	We avoided using training data for other models as calibration, as this would contaminate results
Replication	We deduplicated data by checking for date in the curated UniProt database
Randomization	We conducted random trials across unseen data in the test set for the model.
Blinding	Not relevant to study of protein function, we use data from UniProt which are broadly deposited.
