Data collection	Fluorescence Polarization and inhibition assay data was collected on Spectra Max Paradigm multimode plate reader. The raw data collected from each measurement can be found in the supplementary information. DEL selections data was recorded using Novaseq illumina sequencing
Data analysis	Selection Fingerprint data was displayed and evaluated using MATLAB version R2023b (Mathworks) using a previously reported software (https://doi.org/10.1038/nprot.2016.039). Selection triplicate count data was concatenated using a Python script (given in the Supplementary Information). Fluorescence polarization and Inhibition Assay data was fitted and displayed using PRISM 10. NMR was evaluated using Mestrenova 14.2 software
