Sample size	Sample sizes were selected to have 80% power to identify differentially expressed genes with a fold change of 1.09 and an eqtl slope beta effect of at least 0.13
Data exclusions	We excluded 8 samples based on poor read alignment metrics, 11 due to region discrepancy (consistent with a lab error), 10 due to ambiguous matching based on genotyping data and 12 samples that were of non-European ancestry on principal components.
Replication	We have compared our findings with other published findings, but were limited in a strict replication aim, since there no other comparable post-mortem studies in MDD.
Randomization	Samples were randomized to sequencing batches in order to minimize batch effects in our case-control analyses
Blinding	The investigators were blinded to case status during preparation of the tissue samples
