Sample size

The study contains data from 1208 ± 186 and 991 ± 492 trials, recorded in 7 and 11 sessions from two monkeys respectively, and $(280 \pm 103, 514 \pm 70, 573 \pm 112, 246 \pm 87, 462 \pm 8, 394 \pm 87)$ trials recorded in (12, 4, 6, 3, 2, 2) sessions from 6 mice. In order to capture behavioural diversity across animals and sessions, we chose to include 19 monkey sessions and 29 (shorter) mouse sessions. The exact number of trials is a consequence of how the monkeys and mice behaved during those sessions.

Data exclusions

We did not exclude any trials from the analysed sessions.

Replication

Model performance was tested by using cross-validation, and by splitting the model by session and individual animal. Generalisation was tested in the mice only by a leave-one-out procedure. All these measures were successful in proving the validity of our model.

Laboratory animals

This study involved two macaques (*Macaca mulatta*) of both 15 years old and purchased from the breeding facility in Porton Down, Salisbury (UK); and six C57BL/6J mice (*Mus musculus*), age 10 to 20 weeks, purchased from Charles Rivers Laboratories. The monkeys were housed together in a spacious outside and inside area, connected via a small flap door and containing ample environmental enrichment; mice were day-night reversed and housed in single cages with environmental enrichment, placed in a room with a temperature of 21.5 degrees Celsius and 55% humidity.
