Study description

This study aims to detect amines in water samples, such as tap water samples, by exploiting ECL detection generated from streaming potential using a microfluidic device.

Research sample

Every sample was composed of a solvent (acetonitrile/water mixed in a ratio 3:1, or distilled water, or tap water) with the addition or not of a salt (acting as a supporting electrolyte) and of an additional chemical species such as amines, or aromatic amines, acting as a coreactant.

Sampling strategy

Only tap water samples were sampled from the sink, by collecting water in a clean beaker. No additional treatments were performed on the samples, excluding the addition of amines or aromatic amines. The samples were analyzed within the day. All the other samples were freshly prepared in laboratory by using distilled water or acetonitrile of analytical grade.

Data collection

Data measured with laboratory instruments were collected from the computer by using a pen drive and treated by the same person who analyzed the samples.

Timing and spatial scale

Samples were freshly prepared for every measurement and analyzed within the day. Sample preparation and analysis lasted from April 2022 until February 2024, with a basis of two samples analyzed per week.

No data were excluded from this study.
