Sample size	Perturb-seq data include 788 genes measured and perturbed in 310,385 cells. INTERVAL data include 659 genes in 4732 individuals.
Data exclusions	788 genes were chosen where the estimated per-variance effect-size of the intervention on the target gene was at least -0.75 standard deviations, and where there were at least 50 cells receiving a guide targeting that gene. INTERVAL genes were chosen to overlap Perturb-seq genes.
Replication	Replication was conducted in an independent Perturb-seq dataset of 1,989,578 cells. Identical filtering was applied to arrive at 1429 genes.
Randomization	This is a re-analysis of externally-collected data
Blinding	This is a re-analysis of externally-collected data
