We used simulated datasets: SRR13128012-RR13128014, ERR9765783, and an in-house simulated sample for the ablation experiments and the available public datasets: CAMI II airways (n=10), CAMI II gastrointestinal (n=10), CAMI II skin (n=10), CAMI II oral (n=10), CAMI II urogenital (n=9), human gut (n=104), marine (n=3), and sheep gut (n=1) for benchmarking.
