Study description	A simulation-based analysis projecting the future of coral communities across 3,806 individual reefs of Australia's Great Barrier Reef (bounding box: [142.1942, -24.6428, 153.1491, -10.3526]). Projections were generated using a mechanistic model of coral demography and adaptation through natural selection, driven by heat stress (coral bleaching), and incorporating future exposure to tropical cyclones and coral predator outbreaks under multiple 21st century climate scenarios (emission pathways SSP1-1.9, SSP1-2.6, SSP2-4.5, SSP3-7.0, SSP5-8.5).
Research sample	Forward projections were driven by daily predictions of sea-surface temperatures provided by 10 publicly available coupled atmosphere-ocean general circulation models (AOGCM), selected to represent a representative range of climate sensitivities.
Sampling strategy	Within each emission pathway, the most likely future warming trajectories were estimated using bootstrap sampling across the ensemble of temperature projections, with each AOGCM weighted according to its climate sensitivity.
Data collection	No field data was collected. The model is initialised using historical data on coral cover and coral predator density (<i>Acanthaster</i> spp.) derived from mainstream monitoring programs. The hindcast of coral demographics (2008-2023) are driven by published connectivity data, past exposure to heat stress (NOAA), past exposure to tropical cyclones (Australian Bureau of Meteorology) and concentrations of suspended sediment predicted by the eReefs model. All data are publicly available and can be accessed from the repository of the model (https://github.com/ymbozec/REEFMOD.7.0_GBR). Model projections (2024-2100) are driven by scenarios of future cyclones and future heat stress that can be accessed from the model's repository (https://github.com/ymbozec/REEFMOD.7.0_GBR).

Future cyclones (20 scenarios) were randomly drawn from a database of future cyclone tracks previously established for the Great Barrier Reef. Within each warming scenario, the projected heat stress events were shuffled within each decade of the original forecast (20 randomised sequences for each warming forecast, one for each scenario of future cyclone). The model code includes the 20 seed settings that were used for initialising the random number generator in Matlab, enabling the reproduction of the same sequence of random events that were used for each scenario.
