Sample size	All the statistics is calculated based on sufficient numbers of simulated trajectories to ensure convergence. In our simulations, the number of replicates was chosen based on the intrinsic smoothness of the underlying free-energy landscape, which leads to rapid convergence of ensemble averages and small sample-to-sample fluctuations. This behavior reflects the fact that in our model, the free energy landscape is sufficiently smooth, so that sampling different initial conditions primarily probes similar basins, and statistical fluctuations between replicates are limited. Therefore, the chosen sample sizes are sufficient to obtain stable and reproducible statistics, while remaining computationally efficient. This rationale is consistent with standard practice in computational studies of polymer statistical mechanics and active matter systems.
Data exclusions	No data were excluded from the study.
Replication	Repeated simulations of conformations are tested and the similarity statistics converge well after calculations for many times (shown in supporting figures).
Randomization	Not applicable. This is a computational study with no biological samples or participants. Simulation conditions were pre-specified and held constant across runs; stochastic variability was assessed using independent random seeds. Parameter sets were generated by sampling over predefined grids/ranges, and runs were executed in randomized order to avoid batch effects on shared hardware.
