Reporting on race, ethnicity, or other socially relevant groupings	We did not adjust for ethnicity, as the proportion of missing ethnicity data may have introduced selection bias. Most previous studies that did adjust for ethnicity found little difference to main results when additionally adjusting for ethnicity. There may be residual confounding through lifestyle factors, not captured in the diagnosis-based smoking, obesity and alcohol abuse definitions. Future research may consider more detailed investigations of the role of ethnicity, not just as a confounding factor.

Data exclusions	From the CPRD Aurum database population, cohorts were constructed as described in Figure 1 and Methods. For each outcome-specific analysis, individuals who had the outcome before their index date were excluded (Figure 1).
Replication	We used R version 4.3.1 and organised the research pipeline using the targets R package, ensuring reproducibility of the computationally expensive pipeline.
