Study description	This study performed a new analysis on existing data (national wealth and material production), to develop new worldwide projections for future material demand, and analyse the effect on net CO2 emissions of applying various mitigation strategies. No primary data was generated, and the study was solely desk-based with no experimental, clinical or field work undertaken.
Research sample	The research sample was the countries of the world; the research data was national economic and material production data.
Sampling strategy	A sampling strategy was not relevant for this study; the population in question was national economic and material production data, which was already available in existing datasets. The datasets used are described in the Methods and Supplementary Methods.
Data collection	Data was collected from existing datasets, as described in the Methods and Supplementary Methods. This study analysed existing datasets in a new way; no new, primary data was collected.
Timing and spatial scale	Data was collected by the authors from existing databases, over the time period of 2023-2025.
Data exclusions	As described in the Supplementary Methods (and listed in Supplementary Table 3), certain outlier countries were excluded from the dataset for the top-down analysis. The purpose of this was to obtain master curves that were representative of the global trends, and certain atypical countries were excluded in order to avoid skewing the dataset. These included island nations and petro-states with atypical economic characteristics. Oil-exporting countries (Kuwait, Oman, Saudi Arabia, UAE and Qatar) were outliers, due to their large transient populations, atypical consumption patterns and the large contribution of hydrocarbons to their GDP (>40%).
