Sex (determined based on self-report) was considered in the randomization process (stratified by sex within each center) and was a covariate in the survival analyses. Of the 300 participants, 116 (38.66%) were females.

Physically inactive and sedentary patients with type 2 diabetes of ≥ 1 -year duration, of both sexes, aged 40-80 years, and with a body mass index 27-40 kg·m⁻².

Recruitment

Three hundred eligible patients recruited in 3 outpatients diabetes clinics in Rome from October 2012 to February 2014. Participants signed an informed consent and received no compensation.

Randomization

Stratified by center and, within each center, by age (< versus > 65 years) and diabetes treatment (non-insulin versus insulin), using a permuted-block randomization software that randomly varies the block size (range 4-8).
