Ecological, evolutionary & environmental sciences study design

Study description	This study aimed to optimize enzyme immobilization conditions using a machine learning-driven approach (PHBO). Three enzymes—glucose oxidase (GOx), catalase (CAT), and Candida antarctica lipase B (CALB)—were used as model systems. Workflow: PHBO suggest 8 sets of experimental conditions in parallel based on the prior knowledge database. These 8 experiments were artificially performed to produce 8 kinds of nanohybrids. Then, the activity of nanohybrids were tested, with each sample repeating for 3 times. The mean activity recovery were fed back to the model. PHBO would recommend again in these iterations, until the requirements of researchers were reached.
Research sample	With the help pf PHBO, 88 sets of nanohybrids were synthesized and evaluated for GOx, 56 sets for CAT, and 72 sets for CALB.
Sampling strategy	Parallel experiments independent of each other were used in this study.
Data collection	The data were analyzed by the instrument and then the raw data were copied. The experimental data were recorded by the experimenter in a lab book and an Excel sheet, respectively.
Timing and spatial scale	Each kind of nanohybrids was synthesized for 30-120 min, respectively. For iterations of GOx, CAT, and CALB, the experiments were conducted within 6 months to ensure the consistency.
Data exclusions	No data was excluded.
Reproducibility	All experimental data involving this study were conducted in three parallel experiments to reduce experimental error. For each experiment, a repeat experiment was performed to verify the reproducibility of the results
