Therefore, no active recruitment or self-enrolment occurred, and the likelihood of self-selection bias is minimal. Potential biases include spectrum bias(case mix limited to patients presenting to participating hospitals). The factors may mainly affect the generalizability of the findings. The requirement for informed consent was waived by ethics committees.

Sample size	213 clinical samples were used. We set the target sensitivity (Se) at 90% and specificity (Sp) at 85%. The required numbers of disease-positive (N_pos) and disease-negative(N_neg) samples were approximated using the standard normal approximation for estimating a proportion with a desired precision: $N=(Z^2 \times p(1-p))/d^2$ where Z=1.96 for a two-sided 95% confidence interval, p represents the expected Se or Sp, and d is the allowable absolute error. The estimated minimum sample size is approximately 62 pancreatic cancer cases and 87 controls. So, for training set, we evaluated EnCODE using a clinical serum cohort comprising pancreatic cancer (n=63), benign pancreatic disease controls (pancreatitis, n=50), and healthy controls (n=50). For validation cohort, we collect samples as much as possible(n=50; pancreatic cancer n=20, pancreatitis n=15, healthy n=15).
