Study description

This study focused on the comparison of biogeography and community structure of Eurasian and African large mammal faunas from the last 10 Ma as well as the fossil and modern large mammal faunas.

Research sample

This study include fossil and extant large mammal faunas (Artiodactyla, Carnivora, Creodonta, Perissodactyla, Primates and Proboscidea).

Sampling strategy

The fossil data is collected based on sites which include the fauna, the coordinate, the maximum age, the minimum age, the continent and the country. Body mass categories are logarithmic and classified into 10 levels: 1: <1.67 kg; 2: 1.67–5 kg; 3: 5–15 kg; 4: 15–45 kg; 5: 45–135kg; 6: 135–405 kg; 7: 405–1215 kg; 8: 1215–3645 kg; 9: 3645–10935kg; 10: >10935 kg. Dietary categories were: herbivore, carnivore, and omnivore. Locomotion categories were: ground dwelling, scansorial, arboreal, amphibious, and semifossorial. All the analysis is based on genus level.

Data collection

Fossil data was collected from an online database BICAHEGIS (<https://bicaehgis.cchs.csic.es/>) which includes data from the

Data collection	Paleobiology Database (https://paleobiodb.org/), NOW Database, and new data on 92 Chinese sites that was entered for this study by Jijia Sun. The extant data was collected from IUCN red list and PHYLACINE. The trait data was based on the Paleobiology Database, PanTHERIA, CarniFOSS and literatures.
Timing and spatial scale	The final data of extant mammals was collected from IUCN on 15th, August, 2024. The final data of fossils was collected on 6th, December, 2024.
Data exclusions	Due to size bias against the recovery of very small fossils, taxa belonging to body mass categories 1 and 2 (i.e. < 5 kg) were excluded from all analysis.
Reproducibility	Since the body mass classification for some genera may include more than one category, we conducted multiple repeated analyses to verify the stability and reproducibility of the results.
Randomization	The study was based on pairwise dissimilarity which should contain all the data needed. Randomization is not relevant here.
