Sample size	Cryo-EM data: Sample sizes were not predetermined for this study. 2D classes were used as a guide to determine the sample sizes for the map calculation. Turbidity assays were performed in triplicate (Fig.1 and Fig.6) or in duplicate (Supplementary Fig.9e). Dominant negative assay (Fig.4) was performed in triplicate.
