Mass spectrometry data collection was performed on a 290 Infinity II UHPLC system coupled to a 6470 Triple Quadrupole LC/MS system, with data quantification performed using Agilent MassHunter Quantification Version 9.
Sequencing data was collected on a NovaSeq X Plus instrument with the system's NovaSeq Control Software (v1.3.0).
