Data collection	Recordings were performed using 4 700B Multiclamp amplifiers (Molecular Devices). Signals were digitized at 20 kHz with a CED 1401 power3 AD/DA converter (Cambridge Electronic Design). Pulse generation and data acquisition were performed using Signal software 6.0 (Cambridge Electronic Design). Imaging was done using an Olympus BX61 wide-field and an Andor Dragonfly confocal microscope (dual spinning disk with 25 and 40 μm pinholes, Oxford Instruments).
Data analysis	Data was analyzed using either Stimfit or equivalent Python-based scripts, as well as Matlab- (Mathworks; MATLAB R2024a) scripts. Neurons were reconstructed using Neutube Build Version 1.0z (2018.07.12), which is a Fiji plugin. Plots were generated using GraphPad Prism 10.2.2 and figures were rendered using Inkscape.
