Data collection	NMR measurements were performed with Bruker spectrometers and corresponding Topspin (version 3.7 or 4.0) software. All simulations were performed using the molecular dynamics (MD) simulation software package GROMACS Version 2019.3. The Amber99sbws force field was used in combination with the TIP4P2005s water model. The following algorithms were used: LINCS velocity-rescale, Parrinello-Rahman, Particle Mesh Ewald (PME).
Data analysis	All 2D-NMR data were processed within the UNIX software environment NMRPipe (version 12.6) and were further analysed and visualized using the software package nmrfam-sparky (version 3.190). The software NMRPipe was used to process all pseudo-3D spectra as well as to extract relaxation rates. Measured η_{xy} values were converted using Python (version 3.8) Scripts. The relaxation data was visualized using OriginPRO (version 10.1) software. Spectra were processed, and relaxation rates were extracted using NMRPipe and Mathematica (version 13.3). The NOESY data were processed using NMRPipe and analysed with nmrDraw (version 12.6) and CARA (version 1.9.1). MD simulations were analysed with GROMACS Version 2019.3. Data analysis was performed using the pymc5 package (version 5.15.0) with Python (version 3.11.11). For Markov State analysis, the Python library "Deeptime" (version 0.4.4) was used.
