Sample size	For experiments characterizing inter-participant variation in nasal samples (Supplementary Figs. 6 and 12), samples from five individuals were analyzed. Five participants were considered sufficient to evaluate sample variability and address the reviewers' concerns. For each sample, measurements were performed in triplicate using independently prepared reactions. For the results shown in Fig. 3, a single nasal sample was used and the analyte concentration was titrated. Each analyte concentration was measured in triplicate using independently prepared reactions.

Replication	For experiments with replicates, each reaction was prepared independently and measured in a separate well of the plate. Results from replicates were collected within the same experiment. For experiments comparing experimental conditions with controls (Figs. 3, 4, and 5), each condition was measured in three independent replicates, which were considered sufficient to evaluate the statistical significance of differences between conditions and controls. Characterization of regulatory components (activation and repression behavior) was performed using duplicate measurements, as these experiments were intended to assess regulatory behavior rather than support statistical analysis. De novo binder screening (Fig. 4b,c) and the glucose-readout condition screen were performed as single measurements. In the binder screen experiment, top-performing candidates were subsequently validated in triplicate. For the glucose diagnostic condition screen, a titration gradient provided sufficient resolution to identify optimal conditions without replication.
